- A. Call to Order – 7:07p
- B. Guest Speaker – none
- C. President's Report –
 - 1. Election – Gene had nice talk with Mike Dallas, up to speed on known issues, would approach RCYSL Board as 2-3 year commitment w/ positive energy, cultivate successor
 - i. Sarah: 'retiring' club managers might be good fit for league president successor
 - ii. David: would you give 2 year commitment? what if identified successor bails out? Gene: would be flexible, but definite 2 year commitment
 - iii. Sarah: any procedural issue w/ nominating and electing today? AGM is seating the Board, regular meeting is nominating and electing
 - iv. David motion to nominate Gene as President, DDSC 2nd, all in in favor, no opposed, no abstentions
 - 2. D6 -- none known (Shannon didn't go, not sure if Mike D did)
 - 3. Zoom w/ Union (see draft minutes, attached): discussed whether Brandon w/ come on as Coaching Coordinator for RCYSL, Union happy to support, put together coaching classes, licensing, but doesn't want to be appointed for administrative function, or on the Board; we need a Coaching Coordinator for RCYSL
- D. Club Manager Hot Topics –
 - 1. DDSC: need a Treasurer
 - 2. RSC: had meeting w/ City of Sac Unified, back to fairly normal pricing, port a potties allowed where placed traditionally
 - 3. SOSC/DDSC: bye week schedule good to know soonest (field sharing)

- i. numbers up 130ish from this time last year
- ii. new club Board members and league board members that don't have reg/certs from last year need to reg and complete classes; returning members can register but should wait until after June 1 to complete classes/certs

5. Referee Coordinator –

- i. Need Game Officials straightened out

6. Coaching Coordinator –

- i. RSC: what admin functions would be needed for the position?
 - 1. David: checks w/ club Coaching Coordinators re: coach licensing complete/up to date, coordinates Coaching training, liaison between league and clubs, what do clubs need?
 - 2. Shannon: pull NorCal/USClub definition of Coaching Coordinator
 - a. Allen: min US Soccer D license, role = build a development platform starting from oldest kids on down at club level; from league level, Coordinator could develop the training/development drills and play
 - b. David: league Coord w/ supply training for coaches looking to move up – licensing and/or age group coaching
 - c. RSC: made a handbook for 7v7 & 9v9, happy to share, intend to do an academy style training for U6 & 8; D6 is paying for coach training – they'll pay for D license; Shannon will reach out to D6 to clarify \$\$ support

7. Scheduling Coordinator –

- i. Has D6 mentioned season scheduling changes? EG league, EDC leagues start two weeks earlier than RCYSL/SYSL (EG/EDC don't do seeding); Sat before Labor Day = U8-14 seeding; Fri/Sat after Labor Day = first U6-14 games, 5 weekends of games, bye weekend for reseeding, 5 more weeks of games; Could go earlier and play Sat of Labor Day weekend, could squeeze x2 games into a week/weekend; Club Managers please ask your coaches/families about compressing schedule ideas
 - 1. BAC: what's the impetus to compress the season? Bill: D6 threatens to push District Cup to mid-Nov, then shift it back to Dec b/c RCYSL and SYSL are still playing; other leagues complain b/c their season is over and they wait 3 weeks for District Cup
- ii. Combined league play w/ SYSL – we've got enough numbers to not inter-league for U10s; Gene and Bill will be talking to Shandi
 - 1. Shannon: Fruitridge moved to US Club
 - ii. Spring League: few changes, no seeming problems
 - iv. if team and coaches cleared (and field permit obtained) can start practicing before Aug 1
 - v. Allen: what about moving seeding back one week? Bill still needs a week to construct schedule, so would need to move seeding back two weeks, to play first game last weekend of Aug

MICRO SOCCER RULES

PARTICIPATING CLUBS: Rosemont, Sierra Oaks, St. Ignatius

I. FIELD SET-UP

- a. Field Size: 20yd X 30yd (+/- 5yd)
- b. Lines or a combination of lines and cones can be used to outline field.
- c. Corner flags can be used to help define field.

II. EQUIPMENT

- a. Goals: 4ft X 6ft
- b. Ball size: Size 3
- c. Players: Need their team uniform and shin guards to play. Coaches should have pennies/alternate jerseys (t-shirts) in case playing another team with the same color uniform, i.e. when two teams of the same club play each other.

III. COACHES, REFEREES, & FANS (along touchlines, not goal lines)

- a. Coaches should be with their team along the touchline encouraging play and sportsmanship – not roaming the touchline and/or goal line
- b. The referee on the field will determine possessions, keep running time, direct the game and ensure player safety.
- c. Coaches: Wear badge and bring coaching/player cards to games. **NO COACH CARDS/PASSES = NO COACHING/PLAYING**
- d. All spectators (non-team personnel, e.g. family and friends) for both teams will be along touchlines of the field for the duration of the game.
- e. Set-up/Clean-up: Home team coach is responsible for setting up and putting away goals/cones/flags/signs, etc.
- f. **Note:** U6 games are the primary source for referee training. Allow the referee to do their job and learn how to referee. *Coaches are responsible for their team from the touchline and bench area.*

IV. RULES OF PLAY

- a. Number of Players: 3v3 - No goalkeepers (discourage players hanging back as a de facto goalie)
- b. **Game length:** four 8-minute quarters with a 10-minute half time. One-minute breaks between quarters. Time adjustments can be made to accommodate the weather. Teams switch sides (direction of attack) at half-time.
- c. **Kick Off:** Home team starts with possession, kicking off from center spot.
NOTE: This recurs after any goal scored for the team who was scored upon.
- d. **Out of Bounds**
 - (i) Throw-ins: They should be used as a teaching experience. Referees will accept that throw-ins may not be technically correct but the players should begin to learn to perform throw-ins.
 - (ii) Goal Kicks: A ball kicked out of bounds across the goal line by the attacking team results in a goal kick for the defending team from within their goal box.
NOTE: The defending team must retreat to the midfield line.
 - (iii) Corner Kicks: A ball kicked out of bounds across the goal line by the defending team results in a corner kick for the attacking team from within corner arc of the side the ball went out of bounds.
- e. **No official scores and standings are kept.**
- f. The intent of the game is for **ALL** players to be involved with the play on the field. Coaches should encourage all players to touch the ball before the team scores.
- g. After game: Teams cheer, high-five, shake hands, etc. with each other and with referee if present.

II. SUBSTITUTION RULES

- a. Substitutions may occur during any stoppage of play
- b. Equal playing time for all players.
