- B. Guest Speaker – none
- C. President's Report – Greg O'Connor thanks Board; props to Jose and Catie assisting CPL seeding w/ referees on late notice; mandatory Coach meeting Monday 8/19, big job for Catie big thank you
 - 1. U8 referee issue, request club managers ensure RCYSL meeting actions communicated to club boards; President will modify how potentially contentious issues are approached at RCYSL Board
 - 2. D6: Gold Cup Nov 9&10 Cherry Island (U14^); Nov 23&24 (U10-12) location TBD;
 - i. D6 needs volunteers to help run these tournaments;
 - ii. no Halloween tournament;
 - iii. Yuba planning 1st weekend of Oct tournament, open reg;
 - iv. PAD chair will be Larry Sveitch (CPL or Metro);
 - v. Mercy Rule: after last weekend's games number were very unbalanced, RCYSL doing 'over'scoring have mgrs. remind coaches of Metro and CPL goal differential policies
- D. Club Manager Hot Topics –
 - 1. RSC: play down request, on older BAC U12 team, young 2014, diagnosed autism w/ Drs note and play down, wants to play down w/ sister at RSC U10, mom is an assistant coach, small in stature, probably won't even get 50% of play time, first time playing an organized sport, girl has participated in BAC practices coach was worried about girl's safety
 - i. David: is U10 team first year or second year? RSC thinks team is mixed in birth years
 - ii. Shannon: are there any non-RCYSL U10 teams playing? no
 - iii. Catie: x2 play down requests for autism and APSC Board voted down b/c never played before so don't know level of ability; RSC states BAC coach expressed concern for girl's safety and small size; SISC motion, DDSC 2nd, all AYE, **APPROVED**
 - 2. RSC: combining of CPL w/ Metro in some age groups (due to lack of teams & w/o query to teams) means rec formed teams are playing Select formed teams; coaches are upset and frustrated; Gene offered to provide that information to D6, Derek talked to Sally, Mike Dallas talked to Larry and Sally
 - 3. SOSC: host coach got an abrupt response about seating situation (from NHA; parents on opposite side of kids/coaches, etc); where does SOSC sit at NHA? Discussion of historical practices, D6, what does paperwork required as part of recent RCYSL vote (required by all NHA & Antelope coaches); send RCYSL Board all email re: potentially different rules to compare and contrast; President to investigate w/ D6, club managers to prepare coaches to abide by home field/league rules

RSC: no, b/c the rule is need a ref; non-ref'd games are scrimmages and not official

- G. New Business –
 1. Antelope and NHA joining for Fall '24 league play vote by email; SOSC motion = RCYSL to admit specified U10 and U12 teams from Antelope AYSO and North Highlands (NHA) to our 2024 recreational fall league, as long as all coaches entering the RCYSL league from Antelope and NHA sign written league rule requirements. A committee including the league president, the vice president, and at least two club managers (TBD) will assess the quality of participation of these clubs and their compliance with RCYSL fall league rules and regulations shortly after the end of the season and determine if further actions are warranted, including possible corrective actions or termination of their league involvement; BAC 2nd; discussion re: club or league vote, concerns voiced by VP, age group team numbers; ALL CLUBS AYE, TREASURER AYE (if all Board vote), REGISTRAR AYE (if all Board vote), VP NAY; Secretary, Scheduler, Referee Coordinator did not vote; **APPROVED**
 2. U8 Referees: Info from President via email APSC Board voted over APSC Mgr's objection to continue w/ referees in U8; APSC and BAC = ~1/2 of U8s; Gene suggests abandon coach referee in U8 in light of APSC Board vote; per President will do this once otherwise undermines RCYSL value and efforts
