 - 1. AQ: Sat 7/21 projected unhealthy, anytime over 150 AQI = cancellations; DDSC – need to be consistent, use Union; SISC – like how Cap Valley does it, thinks should be zip of field; permits an issue since school districts canceling events/permit authority
 - 2. U16/19 cancelations up to CPL (EDH is head or schools pulling permits so can't play);
 - 3. Decision made Friday afternoon (~1pm) based on projections for Sat games
 - 4. Motion by Taylor, games cancelled at 150 AQ based on Sacramento general area at IQAir app 2p.m. projection day before game for general time of game (morning, afternoon, night), unless field permits are otherwise suspended, Bill Norris will share info with pertinent partner leagues, 2nd Bill Norris, no opposition or abstention, **APPROVED**

 - i. Need RCYSL ref coord (esp for entry into US Club), to oversee club assignors and assignments

 - i. Need some Age Group Coords (“AGC”) before pkg goes to printer, SOSOC & APSC should shake out a volunteer
 - ii. BAC having permit problems; RSC offers U14 field at Sequoia; still need CPL field for seeding date (8/28), and maybe fields for U12 (Union will check their schedule to see if open field)
 - iii. Suggest distributing seeding info to coaches at beginning of Mandatory Coach Meeting (8/23 @ Cresta); no game cards for seeding
 - iv. APSC permitting Howe Ave Park for CPL (U16/19); APSC having problem liberating goals from Arden MS (construction) & moving; Shannon rec’s to look for goals at Creekside (per John Ebersberger)
 - v. Admin Package email – contact info for everyone + equipment coord, this is important for game day issues, UPDATE please

 1. COVID+ & Exposure Quarantine Protocols:
 - i. will need to be passed to coaches and pertinent other leagues (CapValley, etc)
 - ii. Bill Norris motion to approve, Taylor 2nd:
 1. DDSC: what about close contact definition; per Sarah if using CDPH as reference document, mostly impossible in a soccer scenario;
 2. David: what about neg test of Teammates? per Sarah, contemplated by CDPH, exposed could neg test for first 5 days, that’s why hold period
 3. Mario: what about vax’d; per David, vax’d not making much of a difference
 4. DDSC: no, RSC: no, BAC: yes, APSC: yes, SOSOC: yes, SISC: yes, revises to no, Union: abstain, Bill Norris: yes, David: abstain, Shannon: no, Sarah: yes; 4 no, 6 yes, 2 abstain **APPROVED**
 5. RSC: concern about how to enforce negative test for Team; DDSC: issue = close contact definition; SISC: would change vote given whole Team needing neg test; Mike D: to come back earlier = neg test, or can wait whole 10 day period; RSC told Sac City Unified would adhere to school protocols
 6. Sarah: if revise, need document/guidance want me to follow

7. Union: 'close contact' = 5 days symptom free w/ neg test proof, if no test proof = 10-14 days quarantine; whole team shut down if had Team contact; similar to proposed document and gives decision-power to Board; follows CDC guidance not CDPH; uses CDPH outdoor definition of close contact
 8. Mike D: hearing take Coach responsibilities away and make Club power (aside from reporting); have Coach calling Club Mgr immediately for further instruction
 9. Mike D: do not distribute, has been approved, Mike D. will talk to David and give more direction to Sarah
 2. Larkspur field usage: APSC and SOSC using; RCYSL paying for use of field, but need port-a-potties and lining, Shannon motion: RCYSL will cover ½ cost and anyone else using will split other ½ of cost, David 2nd, SOSC: if the need is there, so be it, no opposition or abstention, **APPROVED**
