Additional Business Discussed:

- Sac North and Natomas partial affiliation for 2012-2013 season.
 - RCYSL received incomplete request from Sac North to partial affiliate for 2012 season.
 - o RCYSL received complete affiliation request for entire club, then withdrawal of U6's via e-mail.
 - Sac North would like to take U8 and U6 in house. Natomas would like to take U6 in house. Natomas is struggling financially and manager may be preparing to retire.
 - Sac North met with US Club soccer and would partial affiliate with US Club. US Club is less expensive than CYSA.

- Sac North has been unhappy with RCYSL for some time and feels that no efforts have been made to develop U8/U6 age groups, nor coaches' development. Still unhappy with RCYSL despite recent change in leadership and current effort to bring a coaching director to RCYSL.
- Savings that Sac North will realize by this move will be directly applied to lower age groups and coach development instead of being disbursed in the larger RCYSL bucket.
- The only reason Sac North has stayed with and would like to continue to stay with - RCYSL is to provide competition for older age groups. Sac North would ultimately not like to be affiliated with RCYSL at all.
- RCYSL and Strategic Planning Committee to discuss impact on League operations and budget, as well as its obligations to CYSA

Future Business:

 Natomas and Sac North partial affiliation request to be the only agenda item for the March 21st meeting.
