
#### **RCYSL Board Meeting**

### April 18, 2012

Approval of minutes from February and March tabled until May meeting due to Secretary absence and final corrections.

### **President's Report:**

- District VI Meeting
  - Cherry Island renegotiated for 20 years. As part of the deal Mark Dickerson needs to reach out to Rio Linda Area to promote a CYSA presence.
  - Field Insurance extended to December 31st, so that liability insurance will run Jan 1st to Dec 31st instead of current Aug 1st to July 31st. Secretary will e-mail extension to all club managers.
  - o Bill Head volunteered to attend the SCUSD meeting on April 20th.
  - District VI has decided leagues need to print the referee "Laws of Game" books from the internet. Some leagues within District VI would still like to combine print order for bulk pricing.
  - Coaching coordinator meeting postponed due to only four attendees. New date TBD. Laptop projector will need to be provided by hosting club/league for all coaching courses.
  - Pre F Train the Trainer (for coaching coordinators) course is set for May 6<sup>th</sup> 11-2 p.m. at Northgate. E-mail announcement was sent out to all club managers, and will be resent. This is a free course.

 District VI will charge an additional \$20.00 per CCSL team, increasing the total team fees to \$100.00.

#### League President's Workshop

- o Children's Hospital had a great presentation on concussions and injuries.
- SB459 effective Jan. 2012 fining organizations for incorrectly filing employees vs. independent contractors 1<sup>st</sup> offense, \$5,000, 2<sup>nd</sup> offense, \$25,000. Everyone that is paid over \$600, other than registrars, needs a W4. CYSA will send out additional information regarding proper classifications.
- CYSA states that all players trying out for a CYSA competitive teams that are not currently a CYSA player must have a completed 1601 on file.
- CYSA North has officially changed its name to Cal North. The new logo and website will be launched May 1<sup>st</sup>. The website will have a translation feature. Coaching courses will be offered in English and Spanish and a new webmail server will be available to the leagues.

#### AGM

- o Fee adjustment proposal did not pass
- o Only motion 4 passed
- CYSA Board of Directors Meeting
  - Eileen presented the district mismanagement of Sac North and Natomas' request to form own league. CYSA agreed with RCYSL grievance and granted RCYSL 90 days to decide on how to handle SN and NSC request. CYSA required SN and NSC to commit all age groups to CYSA if new league was formed. CYSA also required SN and NSC commit to stay with RCYSL if RCYSL was unwilling to give up territory. The following terms were agreed to prior to the CYSA Board meeting, pending RCYSL approval:
  - River City Youth Soccer League's Western boundary will be the Union Pacific Railroad paralleling the East Levee Road from the American River to the Sacramento/Placer County line. MapQuest provides a good view of this area
  - The aforementioned western boundary for RCYSL will be applicable to its recreational program immediately upon approval of the Natomas United Youth Soccer League with the exception of grandfathering Natomas and SNSC practice fields for any Natomas and SNSC recreational teams from the 2011/2012 season choosing to play for a RCYSL Club for the upcoming 2012/2013 season. Given the compressed time frame of the boundary change process and lack of notice to the League membership, a transitory period for teams that have concerns is important to RCYSL in its incumbency. To the extent this creates an accommodation hardship for Natomas United Youth Soccer League due a high number teams requesting grandfathering of their practice fields, RCYSL and the new League will seek arbitration of the issue with District VI.
  - o RCU's use of existing Natomas and SNSC fields will be grandfathered through the 2013/2014 Season.
  - River City United Club's field use will not be limited by the boundary revision referenced above.

- RCU's ability to promote and advertise its program on a timely basis to the players of the Natomas United Youth Soccer League through the 2013/2014 season will be guaranteed.
- Motion made by Rob and second by Bill to approve SN and NSC split as written and agreed above. Motion passed unanimously. Eileen will send notification via email to CYSA and all SN and NSC regarding split. Moving Forward, Shannon will be in charge of all data and League One issues with the transition. Eileen will cover any other issues.
- Food
  - Eileen recommended that we no longer provide food at RCYSL meetings to help keep costs down. All agreed.
- Mather and Rio Linda Area
  - RCYSL will piggyback on Mark Dickerson's commitment for reaching out to these areas to provide CYSA soccer. Currently this area is predominately AYSO.

### Registrar Report:

- Would like to have a Data Consent from RCYSL parents to use registration data in future. Motion was made to give Eileen authority to research and obtain parental consent for RCYSL data usage. Motion passes 9 for 1 against.
- Most clubs have begun registration. Some clubs are having issues with Active Network/L1.

### Referee Coordinator Report:

- Will hold a Referee Coordinator meeting by the end of April or early May, to lay out clinics, policies and principles, assignor courses and fees.
- Referee instructor outside of our league needs to lead the annual renewal in-service.
- July 1st is the deadline for renewing license.
- Will create a card for referees to carry with specifics of modified league rules.

# **Coaching Coordinator Report:**

- CYSA would like Leagues to start tracking injury stats for practices and games.
- CYSA is no longer offering E or ED courses. Instead they will be offering the USSF E and D. There must be at least 1 year between the E and the D course, unless a coach is taking the E course as a refresher course.
