- D. President’s Report
 - 1. District Six Meeting – No Update
- E. Club Manager Hot Topics – AP confirmed that coaches are ok to practice while still pursuing their coaching licenses. Union – Reminded everyone about their Soccer-a-thon at Papa Murphy Park on 8/5/18.

 - 4. Treasurer – Needs Tax return from BAC will reach out to Penny
 - 5. Registrar – Play down request potentially from BAC due to U16 it would need District approval as well for CPL. Several Clubs have too many teams with players over the maximum allowable. Reminder to managers to work with their registrar and coaching coordinators to rework these rosters and recruit additional coaches so we preserve playing time for our players. Team over max without league registrar approval will not be approved or printed.
 - 6. Referee Coordinator /PAD – Sent email reminding everyone of New Referee course on 8/22 – 8/24 and Mandatory In-service training on 8/30 at Arden Dimerick Library.
 - 7. Coaching Coordinator – Cal North courses cancelled due to low enrollment, possibility of scheduling another date in September. 4v4 coaches needing licensure must take the online Cal North 4v4 course. 7v7 – 11v11 should register for and attend the NCSAA course on 8/11 or 8/12. Online 7v7 -1 1v11 option with a postponed field date for coaches who can not attend on 8/11 or 8/12 is being researched. Will notify board w/in a week if this is available. Exceptions/waviers for coaches who cannot attend a 7v7 – 11v11 field course and have no online option, is still a possibility.
