- C. President's Report
 - 1. District Six Meeting – Presidents only; concept to bring Metro League back to District, concept approved, is a select-level league run as recreational
- D. Club Manager Hot Topics – BAC – Oki Park been aerated, seeded, new topsoil, field will be a little rough but playable; St. Ignatius – homeless concerns at General Davies, contact Rob, SSD HOT team will go out on request; AP – permit issue w/ SJUSD and lacrosse resolved
